**Notice Inviting e-Tender No. - MAD/ULB/RAIGANJ/PWD/ 13 /15-16**

("Certified that the e-tender norms of the state government as specified in Finance Department memo nos. 3060-F(Y) dt. 11.06.2014 and 3112-F(Y) dt. 13.06.2014 are being followed by the organization for its procurements".)

1. On behalf of, The Chairman, Board of Administrators, Raiganj Municipality, invites item rate e-Tenders (electronic Tenders) from eligible resourceful & bonafied contractors as per the enclosed list of works (Table - 1)
2. Applicants willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system; through logging on to <https://wbtenders.gov.in> using the option – Click here to Enroll. Possession of a Valid Class II Digital Signature Certificate (DSC) in the form of smart card/e-token in the Company's name is a prerequisite for registration and participating in the Tender submission activities through this web site. Digital Signature Certificates can be obtained from the authorized certifying agencies, details of which are available in the website <https://wbtenders.gov.in>
3. Intending tenderer can search and download NIT and other tender documents electronically by logging on to the website <https://wbtenders.gov.in>, using his Digital Signature Certificate (DSC). This is the mode of collection of tender documents electronically.
4. For participating in the tender, the tenderer shall have to pay the Earnest Money in the form of Demand Draft or Banker's Cheque drawn in favour of Raiganj Municipality payable at Raiganj, Uttar Dinajpur, issued by any Nationalized Bank on/after the date of publication of this Notice, for the amounts mentioned in the list of works under Table-1. The original copies of the Demand Draft towards the Earnest Money Deposit should be submitted in sealed envelopes in the Office of the Chairman, Board of Administrators, Raiganj Municipality, within the date as mentioned in Sl. No.-11, Table-1 positively, super scribing "The Name of the Agency, Sl. No. & Name of the work they applied for.....". Scanned copies of the Demand Draft / Bankers Cheque (Self Attested) for both towards the cost of tender documents (if any) and EMD should be uploaded as Statutory Document / Technical File, which should match exactly with that to be submitted during

making of the Formal documents only after successful procurement of the Tender. Earnest money exemption is not allowed for any category of bidder.

5. *A prospective tenderer shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all his applications will be rejected for that job.*

6. Eligibility criteria for participation in tender:

i) The prospective Tenderers who are eligible to participate (Bonafied Outsider Contractors / Engineers Co.Op. / Labour Co. Op. etc.) should have sufficient resources, financial solvency, sufficient experience & should have satisfactorily completed during the last 5(five) years prior to the date of issue of this Notice at least single work of similar nature for road work under the State/Central Govt. Undertaking, Board/Corporation, Local Bodies or similar Govt. Organization etc., having a magnitude of 50% of estimated amount by completion certificate in support of the credential. Scanned copy of the Completion Certificate issued by the Concerned Executing Authority should be uploaded as Non-Statutory Document through online. Payment certificate/work order/certificate stating work under progress will not be considered as credential in this respect.

ii) Uploading of scanned copies of Pan Card, up to date Income Tax Return receipts, up to date Professional Tax certificate, VAT registration Certificate including up to date VAT Return in the Technical Proposal as Non Statutory Documents.

iii) The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum as Non Statutory Documents.

iv) All Tenderers should have to upload only their self attested copies of the requisite documents in the website for submitting their Tender.

v) Bank solvency certificate (60% of estimated value) is mandatory.

vi) Earnest money exemption is not allowed for any category of bidder.

vii) Audited balance sheet showing up to date accounts.

7. Submission of Tenders

Tenders are to be submitted online through the website, in two folders, at a time for each work, one is Technical Proposal and the other is Financial Proposal, before the prescribed date and time mentioned in Table-1.

Using the Digital Signature Certificate (DSC), the documents are to be uploaded virus scanned and digitally signed. The documents will get encrypted (transformed into non-readable formats).

- iii. In case of any inadvertent typographical mistake the same to be treated to be corrected as to conform to the prevailing relevant schedule of rates or technically sanctioned estimate.
- iv. Necessary deduction i.e. VAT, S.T. I.T. CESS etc. will be made as per relevant Govt. order.

## 8. Financial Proposal

- i) Financial proposal should contain the following documents in one folder i.e. Bill of quantities - (BOQ) the contractor is to quote the rate online. The item wise rates should be inclusive of all charges and taxes including supplying, fitting and fixing all complete as per direction.
- ii) Only downloaded copies of the above documents are to be uploaded virus scanned & digitally signed by the contractor.

9. Penalty for suppression / distortion of facts: If any tenderer fails to produce the original hard copies of the documents uploaded or any other documents on demand of the Tender Inviting Authority within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the Tenderer will be suspended from participating in the tenders on e-Tender platform for a period of 3 (Three) years. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited. Besides, the Chairman, Board of Administrators, Raiganj Municipality may take appropriate legal action against such defaulting Tenderer. The authority may ask to show hard copies of all credentials, certificates, company details, partnership deeds etc. etc. as uploaded by the Tenderer and allied papers in connection with this tender as and when necessary for verification purpose as per convenience of the authority during processing of this tender.

10. Performance Security : Security money will be deducted @10% (regardless of being an Agency or a Co-Operative Society) from the billed amount . No interest will be payable on the EMD/Bid security or the performance security.

CLAUSE 17 OF CONDITIONS OF CONTRACT OF THE TENDER FORM NO. 2911 / 2911 (I) / 2911 (II)  
(VIDE G.O. NO. 177-CRC/2M-57/2008 dt. 12/7/2012) SUBSTITUTED BY THE FOLLOWING:-

"Clause 17" – If the contractor or his workmen or servants or authorized representatives shall break, deface, injure, or destroy any part of building, in which they may be working, or any building, road, road-curbs, fence, enclosure, water pipes, cables, drains, electric or telephone posts or wires, trees, grass or

grassland or cultivated ground contiguous to the premises, on which the work or any part of it is being executed, or if any damage shall happen to the work from any cause whatsoever or any imperfections become apparent in it at any time whether during its execution or within a period of three years after issuance of certificate of its completion by the Engineer-in-Charge, the contractor shall make the same good at his own expense, or in default, the Engineer-in-Charge may cause the same to be made good by other workmen and deduct the expense (of which the certificate of the Engineer-in-Charge shall be final) from any sums, whether under this contract or otherwise, that may be then, or at any time thereafter become due to contractor by the Government or from his security deposit, or the proceeds of sale thereof, or of a sufficient portion thereof and if the cost, in the opinion of the Engineer-in-Charge (which opinion shall be final and conclusive against the contractor), of making such damage or imperfections good shall exceed the amount of such security deposit and/or such sums, it shall be lawful, for the Government to recover the excess cost from the contractor in accordance with the procedure prescribed by any law for the time being in force. The security deposit of the contractor shall not be refunded before the expiry of Three years after the issuance of the certificate, final or otherwise, of completion of work by the Engineer-in-Charge.

Provided that the work shall not be deemed to have been completed unless the "Final Bill" in respect thereof shall have been passed and certified for payment by the Engineer-in-Charge. Provided further that the Engineer-in Charge shall pass the "Final Bill" and certify thereon, within a period of forty five days with effect from the date of submission thereof by the contractor, the amount payable to the contractor under this contract and shall also issue a separate certificate of completion of work to the contractor within the said period of forty five days. The certificate of Engineer-in Charge whether in respect of the amount payable to the contractor against the "Final Bill" or in respect of completion of work shall be final and conclusive against the contractor. However, the security deposit of the contractor held with the Government under the provision of Clause 1 hereof shall be refundable to the contractor in the manner provided hereunder:-

(i) 30% of the security deposit shall be refunded to the contractor on expiry of one year after the issuance of certificate of completion of work;

(ii) Further 30% of the security deposit shall be refunded to the contractor on expiry of two years;

(iii) The balance 40% of the security deposit shall be refunded to the contractor on expiry of three years.

Explanation : - The word 'work' means and includes road work, bridge work, building work, sanitary and plumbing work, electrical work and/or any other work contemplated within the scope and ambit of this contract. The work may be of original or special repair in nature or a combination thereof, or of original or special repair in nature in combination with the work(s) of repair and/or maintenance in nature; Provided that in respect of the work of repair or maintenance in nature or a combination thereof, the words three years wherever appearing in this Clause shall be deemed to be one year and in which case the security deposit of the contractor held with the Government under the provision of Clause 1 hereof shall be refundable to the contractor on expiry of one year after the issuance of certificate of completion of work by the Engineer-in-Charge. The following paragraph shall be added to the Interpretation Clause of CONDITIONS OF CONTRACT:- "The word 'Government' means the Government of the State of West Bengal in Public Works Department." Sale price of bid documents is dispensed with for e-tender / e-bid. In case of re-tender no bid security / EMD is required for the bidders who responded to the first tender but did not get back the EMD deposited with the first bid.

## 11. Rejection of Tender

The employer (Tender accepting authority) receives the right to accept or reject any Tender and to cancel the Tendering process and reject all Tenders at any time prior to the award of contract without thereby incurring any liability to the affected Tenderers or any obligation to inform the affected Tenderers of the ground for employer's (Tender accepting authority) action.

4. The successful tenderer shall have to be executed an agreement with the authority as per usual norms in the Municipal tender agreement form (sample of which is available in the Municipal Office at working hours) within 7 days after the issue of acceptance letter.
5. The contractors shall have to procure all materials including steel and cement as and when necessary as per directive of EIC whose decision regarding brand of cement and steel is final and binding. Cement should not be less than of 43 grade.
6. Recovery of 1% (one percent) for labour welfare cess of gross value of the bills to be made as per regulation of employment and conditions of service act 1996.
7. Site inspection should be made before submission of tender.
8. The authority reserves the right to seek clarification from intending quotationer regarding rate offered of any item e.g. pilling work, which should be proportionate and justified to available Govt. schedule of rates. It is desirable to maintain parity between different components of sub-structure and super structure. In case of parity does not exist and further in case after negotiation with the lowest bidder, if the bidder failed to resolve desired parity, then the rate offered by the lowest bidder is liable to be rejected.
